Subject: Approve and Adopt Resolutions Certifying November 3, 2020 Election Results

Recommended Action

Staff recommends that the City Council approve the attached Resolutions declaring the results of the November 3, 2020 election.

Background

The regular general municipal election for two Daly City Council Members, City Clerk and for Measure Q, regarding an increase to the sales tax, was held on November 3, 2020 and the San Mateo County Registrar of Voters official canvass of returns has been completed. Based upon the election results, staff has prepared resolutions declaring the results of the general municipal election for City Council approval.

The two seats up for election were held by Glenn Sylvester and Juslyn Manalo, whose terms were set to expire November 2020. Both incumbents, Glenn Sylvester and Juslyn Manalo, as well as two other candidates – Shakeel Ali and Musa Nijmeh – filed nomination papers and qualified to run in this election.

The elected City Clerk's term was set to expire November 2020. The incumbent, K. Annette Hipona, as well as one other candidate – Carley-Ann Manalo – filed nomination papers and qualified to run in the election.

The elected City Treasurer's term was set to expire November 2020. The incumbent, Daneca Halverson filed nomination papers and qualified to run in the election. There were no other candidates for the office of City Treasurer.

On July 27, 2020, the City Council adopted a resolution that placed one measure on the ballot:

- Measure Q: An ordinance of the City of Daly City adding Chapter 3.29, Transactions and Use Tax, to Title 3, Revenue and Finance, of the City of Daly City Municipal Code providing for an increase in transaction and use taxes.

The two City Council Members elected to office are Glenn Sylvester and Juslyn Manalo. The City Clerk elected to office is K. Annette Hipona. In addition, Measure Q was approved by a majority of voters. A summary of election results is attached to this report. The Registrar's official canvass of returns is attached to each of the resolutions certifying the results of the election.

Election results, including vote counts and percentages, are as follows:

- Glenn Sylvester: 21,414, 35.01%

THE RESULTS OF THE DALY CITY CONSOLIDATED REGULAR GENERAL
MUNICIPAL ELECTION HELD ON TUESDAY, NOVEMBER 3, 2020 AS TO BALLOT
MEASURE Q: AN ORDINANCE OF THE CITY OF DALY CITY ADDING CHAPTER 3.29,
TRANSACTIONS AND USE TAX, TO TITLE 3, REVENUE AND FINANCE, OF
THE CITY OF DALY CITY MUNICIPAL CODE

A. That the general Municipal Election was held in the City of Daly City on November 3, 2020, in accordance with the appropriate provisions of the Government Code of the State of California and of the Elections Code of the State of California.

B. Pursuant to Resolution No. 20-78 of this City Council, the County Clerk of the County of San Mateo was authorized and instructed to certify to the City Council the record of votes cast in the general Municipal Election and has made his certificate and report thereof to the City Clerk.

C. Pursuant to Resolution No. 20-131 of this City Council, Measure Q was authorized to be placed before the voters.

D. That at the aforementioned general Municipal Election, the following Measure to be voted on:

Measure Q: An ordinance of the City of Daly City adding Chapter 3.29, Transactions and Use Tax to Title 3, Revenue and Finance of the City of Daly City Municipal Code.

E. Pursuant to the provisions of Section 22932 and 22933 of the Elections Code of the State of California, the City Council of the City of Daly City desires to canvass the returns of said election and to declare the results of the local measure placed upon that ballot by the City of Daly City
