PUBLIC HEARING:

1. **Use Permit UPR-12-18-13808.** To convert a portion of an existing single-story commercial building at 75 Pueblo Street to include one 723 square foot studio apartment with one parking space. The project is exempt from the California Environmental Quality Act (CEQA), pursuant to CEQA Guidelines Section 15301 - Minor Alteration of Existing Public or Private Structures. APN 005-063-130

2. **Use Permit UPR-12-18-13791 (Sign Program Amendment).** To amend the

existing sign program for the DC Station Office Building located at 2001 Junipero Serra Boulevard. The proposed sign program would allow signs in current locations, but add signs mid-height at the existing office building's walls. The project is exempt from the California Environmental Quality Act (CEQA), pursuant to CEQA Guidelines Section 15305 - Minor Alterations in Land Use Limitations). APN 002-362-400.

3. **Zone Text Amendment ZC-09-18-13672, Use Permit UPR-8-18-13628 and Design Review DR-3-18-13329.** To construct a revised street façade and three-story rear addition to an existing church located at 45 County Street. The addition would provide 2,632 net additional square feet for the purpose of providing additional office, classroom, and multipurpose space. The applicant has requested a Zone Text Amendment modifying the parking regulations pertaining to churches to allow the proposed expansion. The project is exempt from the California Environmental Quality Act (CEQA) per CEQA Guidelines Section 15061(b)(3) - Review for Exemption. The proposed Zone Text Amendment would apply city-wide. 4. **Use Permit UPR-12-18-13790.** To make minor modifications to the existing golf course located at 2300 Junipero Serra Boulevard. The proposed modification consists of moving the course's existing driving range onto the part of the course presently occupied by the 10th hole on the property presently occupied by the driving range. The project is exempt from the California Environmental Quality Act (CEQA) Guidelines Section 15301 - Minor Alteration of Existing Public or Private Structures. APN 002-410-050.
