Those comments received after 4:00 pm will be added to the record and shared with the Small Business Commission members following the public meeting. Comments are not read aloud into the record.

The name entered will be visible online and will be used to notify you that it is your turn to speak. When you would like to speak on an item during the public comment portion of the meeting, you will need to use the "raise hand" feature in Zoom. The City will not be providing technical support.
