Appointment of Interim City Manager

City Attorney Rose Zimmerman presented the Council's recommendation to appoint Thomas Piccolotti as Interim City Manager until such time the City Council appoints a permanent City Manager, for a period not to exceed six months. Ms. Zimmerman discussed the recruitment process for a permanent City Manager and provided information on Mr. Piccolotti's many years of experience in local government. Mr. Piccolotti has spent 22 years working for the City of Daly City. Staff will present the Employment Agreement for the Interim City Manager at the regular meeting of September 12, 2022 for City Council approval.
